#### Megan O'Keefe, Executive Director Caregivers Volunteers of Central Jersey



Megan O'Keefe is the Executive Director of Caregivers Volunteers of Central Jersey, a non-profit that provides over 30,000 hours annually of free supportive services to seniors to help them age in their homes as a part of their community. To help Caregiver Volunteers navigate new challenges in implementing their volunteer program during the pandemic, she led a digital strategy that streamlined workflow, allowing staff to run the program remotely. These automated processes increased capacity without adding fixed overhead costs. They collected program data to provide real-time insight to trends in service requests and grow their database from 4,000 to 11,000 people. Since the implementation of this system, Caregiver Volunteers has been able to grow their core programs in Ocean and Monmouth Counties and will be adding two new services in 2023- The Handy-Andy, a volunteer handyman service for seniors, and The Health Hop, a partnership with Uber Health to arrange rides to medical appointments for seniors.
