


- Go to scrimmage.njsbf.org



Click on “Request a Scrimmage”

- Scroll down the page to see all available Scrimmage Partners
- Select the Scrimmage Partner that best meets your criteria (e.g., county, method, day of the week)
- An email form will generate (pre-populated with your name and email information).
 - Add a message in the message box with any specific date or time requests.
- An email will be sent to contact at the Scrimmage Partner School requesting a match-up.
- The Scrimmage Partner School will respond to you directly (via email) to schedule.
